The Gordon County accepted sealed written bids from qualified vendors to supply a 2013 Passenger Van for the Senior Center with center isle, grab bar, running boards, entry door step..

Bid documents were prepared and distributed to potential bidders, posted on the county's web site, and posted on the Government e-procurement web site. In addition, an Invitation to Bid announcement was published in the Calhoun Times on June 5, and 12, 2013. The deadline to submit sealed bids was 2:00 p.m. on June 19, 2013. County staff opened the bids received at that time in a public bid opening. Below were the responses:

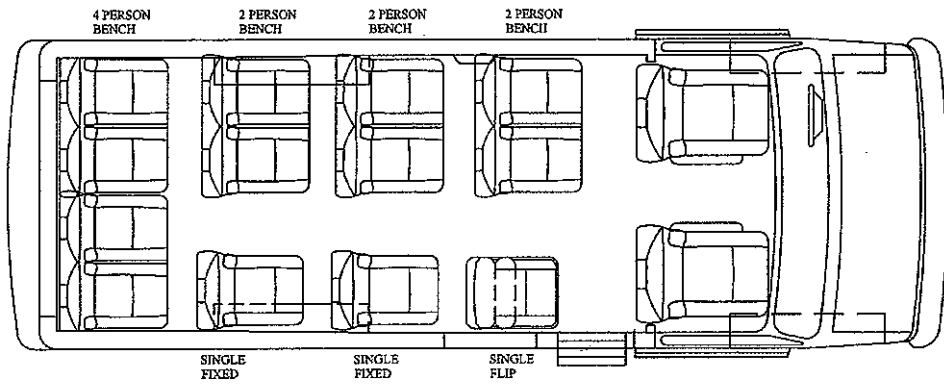
