

**GORDON COUNTY, GEORGIA

The Gordon County Board of Commissioners accepted Qualification packages from 9 companies. A committee consisting of Chairman Hood, Commissioner Sexton, John King, Jeff Champion, Tom Burgess, Martin Vaughn and Representatives of Pieper, O'Brien, Herr Architects met to evaluate the qualifications. Four highly qualified companies were selected to bid on the Parking Deck project. They are listed below. Bids were accepted for the project on September 23, 2014 in a public bid opening. Below is the response:

County staff has evaluated the submitted bids and accompanying documents.

RECOMMENDATION

The staff recommends RA-LIN and Associates as the contractor to build the new parking deck at a cost of \$2,070,593.00 with a contingency of \$100,000.00. The contract with RA-LIN and Associates would be in the amount of \$2,170,593.00.

This will be covered by the amount collected via the SPLOST for this purpose.
