**Conference Registration Package** includes a Lifelong Learning Academy class on either October 7 or October 9 and all other conference sessions on October 8. All meeting materials and banquet events are included in this registration package.

**Second Training Day** includes a second Lifelong Learning Academy class when registering in conjunction with the Conference Registration Package. The second class can be on either October 7 or 9, and the registration fee covers all course materials, breakfast and lunch on the second training day.

Spouse/Guest includes all banquet events and sessions except Lifelong Learning Academy classes.

#### **Conference Housing**

If registrants need housing at the convention hotels, please provide the reservation details on the registration form for each individual reservation. <u>The housing cut-off date is Thursday, September 3, 2015.</u>

There are four conference hotels in Jekyll Island:

■ The Hampton Inn & Suites

Rates: \$139 standard room, \$159 Studio Suite

The Holiday Inn Resort

Rates: \$125 islandview, \$145 oceanview, \$175 oversize oceanview (microwave, small refrigerator, balcony or patio), \$215 oceanfront suite (sitting area, kitchenette, private balcony)

Jekyll Island Club Hotel

Rates: \$189

The Westin Jekyll Island

Rates: islandview \$179, oceanview \$209

- Additional resort fees may apply at all hotels. Please pay special attention to the confirmation you receive from the hotels. In addition, hotels may have an early departure fee if you check out earlier than the reservation date. Again, look for more information on the hotel confirmation.
- Here's the reservation process:
  - ACCG will forward reservation requests to one of the conference hotels based on the information you provide on the registration form. This will include any credit card you give us here.
  - ACCG will make every effort to honor the first hotel you select. However, it may not always be possible to do so. Please provide at least four hotel choices on your registration. If you provide only one choice and that choice is not available, we will have to contact you for additional choices and it will delay the processing of your registrations.
  - ACCG will also try to keep county attendees housed in the same hotel, unless your registration makes it clear that your registrants prefer different properties.
  - You will receive an email confirmation from the hotel on your reservations. Advance payment for the hotel should be sent directly to the assigned hotel, after you have received your email confirmation for the reservation. Please do not send any housing payments to ACCG at this time wait until you receive your confirmation from the hotel, then send checks directly to it.

- We realize you are anxious to know your hotel assignments. ACCG processes your reservations as quickly as possible; don't forget that final processing can be delayed by failing to send your check payment for registrations in a timely manner. In addition, the conference hotels process their reservations on different time-tables so some reservations may be confirmed well in advance of others, even if they were submitted at the same time.
