The Gordon County Board of Elections and Voter Registration conducts municipal elections for the following municipalities:

- **City of Calhoun**-qualifying begins at 8:30 a.m. Monday, August 16th and will end on Wednesday, August 18th at 4:30 p.m.
- **City of Plainville**-qualifying begins at 8:30 a.m. Tuesday, August 17th and will end on Thursday, August 19th at 4:30 p.m.
- **City of Fairmount**-qualifying begins at 8:30 a.m. Monday, August 16th and will end on Wednesday, August 18th at 4:30 p.m.
- **Town of Resaca**-qualifying begins at 8:30 a.m. Monday, August 16th and will end on Wednesday, August 18th at 4:30 p.m.

To cast your ballot during early/advance voting you will go to the Gordon County Board of Elections and Voter Registration Office located (across the street from the Post Office) at 408 Court Street, Calhoun, Georgia.
