ORDER FOR PRE-TRIAL CALENDAR AND HEARINGS

You are hereby notified that the cases on the enclosed calendar will be called for pre-trial conference under Code Section 9-11-16 and Uniform Superior Court Rule 7, on Tuesday August 10, 2021, at the **time stated on the calendar, in the MAIN Courtroom, Calhoun, Georgia.** By direction of the Judge, pre-trial will not be reassigned nor removed from the calendar except upon legal grounds and by the order of the court.

The form of the pre-trial order and subject matter to be covered at the pre-trial shall be as contained in Uniform Rule 7. Counsel for both parties may agree on a written order prior to the pre-trial conference provided appropriate subjects are covered in the proposed order: however lead counsel for each party must attend the conference. In the event of an agreed order, the same shall be signed by both counsel and presented to the court for approval at the time scheduled for the pre-trial conference. In the event an order is not agreed upon, each counsel shall submit a proposed order.

In the interest of time, counsel should exchange, **prior to the pre-trial conference**, all photographs, medical bills and other documentary and real evidence proposed to be used on trial and be prepared at the pre-trial conference to advise the court of those exhibits which: (1) may be submitted without further proof, or (2) may be admitted into evidence without further proof of authenticity.

Failure to comply with the terms of this pre-trial order will authorize the court to exclude exhibits at trial. Should a party or counsel fail to appear at the pre-trial conference, an ex-parte hearing may be held or other appropriate action taken.

Any case not settled before pre-trial conference is ordered to mediation. All counsel shall be prepared to discuss possible mediation dates with each other on the date of pre-trial conference.
