Dear Mr. King:

This Office is currently in possession of the following property:

- *Remington*® Model 700 .308 caliber rifle, serial number **G 6602444** equipped with a *Leopold*® telescopic sight, serial number **351966 L**, sling, swivels, bipod, and contained within a hard plastic carry-case.
- *Remington*® Model 700 .308 caliber rifle, serial number **G 6394502**, equipped with a *Leopold*® telescopic sight, serial number **1511022 L**, sling, swivels, bipod, and contained within a hard plastic carry-case.
- Two thousand, five hundred (2500) rounds of *Federal*® .308 caliber ammunition.

This property has been in secure storage since Sheriff Ralston took Office on 1st January, 2009, and has remained unused since that date. This Office has no use now, nor foresees any use in the future, for these items.

On 18th May, 2015, '*GT Distributors*', a nationally recognized and reputable police equipment vendor with whom this Office has transacted business for many years, offered for trade three (3) *Colt*® AR15 .223 rifles with certain accessories (see attached proposal from *GT Distributors* dated 5/18/2015) in exchange for the property listed above. The AR15 rifle is the type weapon which is currently issued to our deputy sheriffs in the Uniform Patrol Division. The acquisition of three (3) new weapons would augment our existing stock, allowing us to have at least two (2) extra rifles on hand in the event that any which are now issued should require repair or refitting, without entailing any purchase of new equipment.

Therefore, we request that the Board of Commissioners consider declaring the property listed above as surplus property, and approving the exchange of said property to '*GT Distributors*' for the aforementioned new equipment (weapons and accessories) as proposed, at the earliest opportunity.
