1. GENERAL CONTRACT PROVISIONS:

- (a) The contract made and entered into by and between the **PROSECUTING ATTORNEYS' COUNCIL OF GEORGIA**, an agency of the Judicial Branch of the State of Georgia legally empowered to contract pursuant to O.C.G.A. §§ 15-18-44 and 15-18-20.1 and as otherwise identified in Section 2 of this contract extension, and hereinafter referred to as the COUNCIL and

legally empowered to contract pursuant to the laws of the State of Georgia, and hereinafter referred to as the CONTRACTOR, dated July 1, 2009, (hereinafter referred to as the "original contract") is hereby extended for the period of time specified in Section 2 of this contract.

2 (b) This contract extension is deemed to be made under and shall be construed and  
3 enforced in every respect according to the laws of the State of Georgia. Any lawsuit  
4 or other action based on a claim arising from this Contract shall be brought in a court  
5 or other forum of competent jurisdiction within Fulton County, State of Georgia.  
6  
7 (c) Nothing contained in this contract shall be construed to constitute the  
8 CONTRACTOR or any of its employees, agents, or subcontractors as a partner,  
9 employee, or agent of the COUNCIL, nor shall either party to this contract have any  
10 authority to bind the other in any respect, it being intended that each shall remain an  
11 independent contractor.  
12  
13 (d) By executing this contract extension, the CONTRACTOR warrants and guarantees  
14 that the resolution or resolutions adopted by the governing authority of the county or  
15 counties covered by the original contract which authorized the District Attorney for  
16 the **Cherokee Judicial Circuit** to enter into this contract on behalf of said county or  
17 counties as provided in O.C.G.A. § 15-18-21.1 remain in full force and effect. Said  
18 resolution or resolutions, copies of which are annexed to the original contract are  
19 incorporated herein by reference as fully set forth.

21 **2. PERIOD OF CONTRACT:**

22  
23 This contract extension is effective as of the **1st day of July, 2017**, and shall terminate on the  
24 **30<sup>th</sup> day of June, 2018**, unless terminated earlier under other provisions of this contract.

26 **3. COUNCIL AND CONTRACTOR CONTACT INFORMATION:** Unless otherwise  
27 stated herein, the COUNCIL and CONTRACTOR contact information set forth in the  
28 original contract shall be the same for the period of this contract extension. Either party may  
29 change such information during the term of this contract extension by written notification to  
30 the other party.

32 **4. SCOPE OF SERVICES.** The Scope of Services set forth in the original contract shall  
33 remain the same during the term of this contract extension.

36 **5. COUNTY PAYMENTS TO THE COUNCIL:**

38 (a) The approved contract budget for the period of this contract as identified in Section 2  
39 is **\$387,836.73**.

41 (b) The Contractor will pay the Council monthly payments for reimbursement of total  
42 allowable expenditures as invoiced monthly which are within the approved budget.

44 **6. CONTINUATION OF OTHER ORIGINAL CONTRACT PROVISIONS.** The  
45 provisions of Sections 3 through 24 of the original contract shall remain in full force and  
46 effect during the term of this contract extension, unless modified in accordance with Section

1 9 of the original contract, and such provisions are incorporated herein by reference as if fully  
2 set forth.
