

AGREEMENT

WHEREAS, Article 9, Section 2, Paragraph 3 of the Georgia Constitution specifically confers upon GORDON COUNTY, GEORGIA, a political subdivision of the State of Georgia (hereinafter referred to as "the County"), certain supplementary powers and all implied powers necessary to carry out said supplementary powers and provide services to include public health facilities and services, parks, recreational programs, libraries, archives, and arts and science programs and facilities; and

WHEREAS, the County has been requested by the WINNER'S CLUB (hereinafter referred to as "the Service Provider") to furnish funds in the amount of \$4,550.00 for the County's fiscal year ending June 30, 2019 to allow the Service Provider to perform the following activities promoting the safety, health, peace, security, good order, comfort, convenience and general welfare of the citizens of the County, to wit:

Provide recreational programs for disadvantaged youth that have been identified as "at risk" students by local law enforcement and educational personnel; supervise persons ordered to perform community service by the local court system; and

WHEREAS, the Board of Commissioners of Gordon County, Georgia consider the services to be performed by the Service Provider necessary for the general welfare of the citizens of Gordon County;

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt whereof is hereby acknowledged, the County and Service Provider do hereby agree as follows:

Service Provider will provide to the County a report on or before December 31, 2018 and May 31, 2019 identifying the activities, projects and programs performed or completed during said reporting period. Said report shall identify the costs and expenditures for same as well as the number of County residents served.

3. County will pay to the Service Provider the sum of \$4,550.00 for the Service Projects.

4. Any property, other than real estate, purchased by the Service Provider with the funds paid by the County hereunder shall become the property of the County in the event the Service Provider ceases to exist as a legal entity or abandons the Service Project. In such event, the County may take immediate possession of said property.

WHEREAS, the County has been requested by PREVENT CHILD ABUSE GORDON COUNTY, INC, (hereinafter referred to as "the Service Provider") to furnish funds in the amount of \$5,000.00 for the County's fiscal year ending June 30, 2019 to allow the Service Provider to perform the following activities promoting the safety, health, peace, security, good order, comfort, convenience and general welfare of the citizens of the County, to wit:

Parenting and nursing classes to parents and their children, ages 0-18, who are mandated by the courts to attend where abuse and neglect has already occurred, and those who voluntarily feel the need to attend classes in an all-out effort to prevent child abuse and neglect by teaching parenting and nurturing skills to provide parents with ways to discipline and nurture their children while teaching them how to become productive citizens through learning communication techniques, and to empower families so that they can contribute to the safety, health, peace, security, good order, comfort, convenience, and general welfare of the citizens of Gordon County ; and

WHEREAS, the Board of Commissioners of Gordon County, Georgia consider the services to be performed by the Service Provider necessary for the general welfare of the citizens of Gordon County;

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt whereof is hereby acknowledged, the County and Service

Provider do hereby agree as follows:

1. Service Provider will undertake and perform the following activities, projects and programs (hereinafter referred to as "the Service Project") during the County's fiscal year ending June 30, 2019:

Parenting and nursing classes to parents and their children, ages 0-18, who are mandated by the courts to attend where abuse and neglect has already occurred, and those who voluntarily feel the need to attend classes in an all-out effort to prevent child abuse and neglect by teaching parenting and nurturing skills to provide parents with ways to discipline and nurture their children while teaching them how to become productive citizens through learning communication techniques, and to empower families so that they can contribute to the safety, health, peace, security, good order, comfort, convenience, and general welfare of the citizens of Gordon County.

2. Service Provider will provide to the County a report on or before December 31, 2018 and May 31, 2019 identifying the activities, projects and programs performed or completed during

said reporting period. Said report shall identify the costs and expenditures for same as well as the number of County residents served.

3. County will pay to the Service Provider the sum of \$5,000.00 for the Service Projects.

4. Any property, other than real estate, purchased by the Service Provider with the funds paid by the County hereunder shall become the property of the County in the event the Service Provider ceases to exist as a legal entity or abandons the Service Project. In such event, the County may take immediate possession of said property.

WHEREAS, the County has been requested by HAND UP, INC., A VOLUNTARY ACTION CENTER, (hereinafter referred to as "the Service Provider") to furnish funds in the amount of \$9.919.00 for the County's fiscal year ending June 30, 2019 to allow the Service Provider to perform the following activities promoting the safety, health, peace, security, good order, comfort, convenience and general welfare of the citizens of the County, to wit:

Provide energy assistance for residents of Gordon County who qualify; provide rental assistance for those individuals who are in the process of being evicted; provide temporary shelters; assist the Gordon County Health Department with some medical assistance; supply clothing for members of the Work Detail; provide food for those in need, as well as, clothing and household items for those who suffered a house fire or other natural disaster; assist children with Operation Happy Christmas; and assist those re-entering the work force with appropriate clothing at very little cost; and

WHEREAS, the Board of Commissioners of Gordon County, Georgia consider the services to be performed by the Service Provider necessary for the general welfare of the citizens of Gordon County;

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt whereof is hereby acknowledged, the County and Service Provider do hereby agree as follows:

WHEREAS, the County has been requested by CALHOUN-GORDON ARTS COUNCIL (hereinafter referred to as "the Service Provider") to furnish funds in the amount of \$4,550.00 for the County's fiscal year ending June 30, 2019 to allow the Service Provider to perform the following activities promoting the safety, health, peace, security, good order, comfort, convenience and general welfare of the citizens of the County, to wit:

Enhance the quality of life in Gordon County by providing theatre and music events to the community through live performances for all age groups and continue efforts to promote Roland Hayes by educating and preserving his accomplishments by creating a museum in his memory; offering free admission to the art galleries and the Roland Hayes Museum to all visitors; art shows, with 2 being devoted entirely to the work of Gordon County and Calhoun City Schools students; providing The Art Market museum store for Gordon County artists; hosting the Georgia String Band Festival; providing and promoting art activities in Gordon County such as the Music Guild, Calhoun Little Theater, and the Community Chorus; and offering classes in the music and the arts for Gordon County residents; and

WHEREAS, the Board of Commissioners of Gordon County, Georgia consider the services to be performed by the Service Provider necessary for the general welfare of the citizens of Gordon County;

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt whereof is hereby acknowledged, the County and Service Provider does hereby agree as follows:

1. Service Provider will undertake and perform the following activities, projects and programs (hereinafter referred to as "the Service Project") during the County's fiscal year ending June 30, 2019:

Will provide theater and music events to the community for all age groups, will present the Roland Hayes Festival in conjunction with Georgia Music Week, will host the Georgia String Band Festival, will host, promote and support student and regional art shows in the gallery, and will continue to work toward the establishment of a permanent home for the arts in Gordon County.

2. Service Provider will provide to the County a report on or before December 31, 2018 and May 31, 2019 identifying the activities, projects and programs performed or completed during said reporting period. Said report shall identify the costs and expenditures for same as well as the number of County residents served.

3. County will pay to the Service Provider the sum of \$4,450.00 for the Service Projects.
4. Any property, other than real estate, purchased by the Service Provider with the funds paid by the County hereunder shall become the property of the County in the event the Service Provider ceases to exist as a legal entity or abandons the Service Project. In such event, the County may take immediate possession of said property

**AGREEMENT
CITY SCHOOL NURSE SERVICES**

This Agreement is made effective as of the First day of July, 2018, by and between Gordon County, a political subdivision of the State of Georgia (hereinafter referred to as the "County") and the Calhoun City Schools (hereinafter referred to as the "City-Schools").

WHEREAS, the County and the City Schools agree that the health of the children enrolled in the Calhoun City School System is a matter of public concern; and

WHEREAS, the provision of limited medical services to the children of Gordon County while attending the Calhoun City School System will promote the general welfare of all citizens of Gordon County; and

WHEREAS, the County wishes to continue to support the School Nurse Program which is currently in place within the Calhoun City Schools and is administered by the City Schools; and,

WHEREAS, it is in the best interest of the public health, safety and welfare of all Gordon County citizens for medical care to be provided to the children attending the Calhoun City public schools through utilization of the School Nurse Program.

NOW THEREFORE, in consideration of the mutual covenants and promises hereinafter contained, and other good and valuable considerations, the receipt and sufficiency of which is hereby acknowledged, it is agreed as follows:

1. The County shall pay to the City Schools by and through its Board of Education the amount of \$34,125.00 (Thirty-Four Thousand One Hundred Twenty-Five and 00/100) with said amount to be used for the Calhoun City School Nurse Program. These funds shall be used by the City Schools for the school year budget period beginning on July 1, 2018 and ending on day of June 30, 2019.
2. The City Schools agree to utilize these funds solely for the purpose of providing medical care, treatment, and prevention programs to the children of Gordon County through the School Nurse program offered by and at the Calhoun City Schools.
3. The parties agree and understand that any employees, providers, agents or officials employed or utilized in any manner in the provision of any medical care, treatment, and prevention programs to the children through the School Nurse program offered by and at the Calhoun City Schools are not employees of, agents of, or employed by Gordon County Government and its Board of Commissioners. It is further agreed by the parties that it is the sole responsibility and

discretion of the City Schools as to who they employ or utilize to provide these medical services through the School Nurse program.

4. Should the City Schools decide to discontinue the School Nurse Program, then the City Schools agree to reimburse to Gordon County any funds which have been paid by the County but have not been expended by the Calhoun City Schools for the operation of the School Nurse program during the 2018-2019 school year.

5. The parties agree to comply with all applicable Federal and State laws, rules, and regulations, and local ordinances now in effect or later adopted. Any notices, requests, comments, and other communications required or permitted under this Agreement shall be in writing and shall be hand delivered or mailed by registered or certified mail, return receipt requested, addresses as follows:

**AGREEMENT
COUNTY SCHOOL NURSE SERVICES**

This Agreement is made effective as of the First day of July, 2018, by and between Gordon County, a political subdivision of the State of Georgia (hereinafter referred to as the "County") and the Gordon County School District (hereinafter referred to as the "County Schools").

WHEREAS, the County and the County Schools agree that the health of the children enrolled in the County School System is a matter of public concern; and

WHEREAS, the provision of limited medical services to the children of Gordon County while attending the County School System will promote the general welfare of all citizens of Gordon County; and

WHEREAS, the County wishes to continue to support the School Nurse Program which is currently in place within the County Schools and is administered by the County Schools; and,

WHEREAS, it is in the best interest of the public health, safety and welfare of all Gordon County citizens for medical care to be provided to the children attending the County public schools through utilization of the School Nurse Program.

NOW THEREFORE, in consideration of the mutual covenants and promises hereinafter contained, and other good and valuable considerations, the receipt and sufficiency of which is hereby acknowledged, it is agreed as follows:

1. The County shall pay to the County Schools by and through its Board of Education the amount of \$34,125.00 (Thirty-Four Thousand One Hundred Twenty-Five and 00/100) with said amount to be used for the County School Nurse Program. These funds shall be used by the County Schools for the school year budget period beginning on July 1, 2018 and ending on day of June 30, 2019.
2. The County Schools agree to utilize these funds solely for the purpose of providing medical care, treatment, and prevention programs to the children of Gordon County through the School Nurse program offered by and at the Gordon County Schools.
3. The parties agree and understand that any employees, providers, agents or officials employed or utilized in any manner in the provision of any medical care, treatment, and prevention programs to the children through the School Nurse program offered by and at the Gordon County Schools are not employees of, agents of, or employed by Gordon County Government and its Board of Commissioners. It is further agreed by the parties that it is the sole responsibility and

discretion of the County Schools as to who they employ or utilize to provide these medical services through the School Nurse program.

4. Should the County Schools decide to discontinue the School Nurse Program, then the County Schools agree to reimburse to Gordon County any funds which have been paid by the County but have not been expended by the County Schools for the operation of the School Nurse program during the 2018-2019 school year.

5. The parties agree to comply with all applicable Federal and State laws, rules, and regulations, and local ordinances now in effect or later adopted. Any notices, requests, comments, and other communications required or permitted under this Agreement shall be in writing and shall be hand delivered or mailed by registered or certified mail, return receipt requested, addresses as follows:
