Darryl Edwards has called again regarding the letter from Gordon County pertaining to the DeAnnexation of property from The City of Calhoun back into Gordon County. As per our previous conversation the property will only be in the county for a short time until the City of Resaca can move to annex the same parcel into their jurisdiction to be combined with the existing Northpointe Subdivision. Hi Mr. Edwards,

Just a reminder that I will need the resolution from the Gordon County Commissioners stating they will accept the property back into the county as being a portion of the unincorporated area before your request can be placed on the agenda for a first reading, which is scheduled for August 16th.

Obviously time is of the essence in Mr. Edwards having the ability to complete the first phase of this process without the unnecessary delay associated with beginning the process over and sending new notices to the adjoining landowners before the deannexation can proceed.
