Your health & safety are very important to us!

Due to the rising number of COVID cases, we are requiring all participants to adhere to the following health and safety protocol:

- If a participant is experiencing any symptoms associated with COVID-19 (coughing, congestion, fever, etc.) in the days prior to March 9th, ACCG asks that the participant get tested for COVID-19. If the test results are positive, ACCG requests that the participant NOT travel to the event, but rather contact ACCG to request a 100% refund of fees paid.* If the test results are negative, and the participant still plans to attend, ACCG asks that the participant wear a face covering that completely covers the mouth and nose, at ALL times during the event except when eating/drinking.
- Participants who are not fully VACCINATED will be required to wear a mask or face covering that completely covers the mouth and nose, at all times except when eating/drinking.
- For all FULLY VACCINATED participants, ACCG strongly recommends, but will not require, the wearing of a mask or face covering that completely covers the mouth and nose at all times.

- With respect to any participant who is FULLY VACCINATED and has chosen to not wear a face covering, if that participant is displaying any symptoms associated with COVID-19 (coughing, congestion, fever, etc.), ACCG reserves the right to require that participant to wear a face covering for the duration of the event. **Failure to comply with this requirement may result in dismissal from the event.**
- ACCG strongly recommends maintaining a minimum of six feet of physical distance between you and all other participants at all times.
- ACCG strongly recommends, but will not require, avoidance of physical contact with other participants at all times.
- ACCG reserves the right to take temperatures with a digital, touchless thermometer, and deny admission to anyone who tests over the threshold.
