**Registration is first-come, first-served.** Participants **must register through their county clerk**. There are enrollment caps for each class. We will establish and maintain a waiting list once a class becomes full.

**Clerks**, please remember that you will need to LOGIN to the ACCG Registration Database to access registration.

**Registration fees:** Each 1-Day class is \$235 per person, per day. The 2-Day CORE: Property Appraisal & Taxation class is \$380.

**Lodging:** We have reserved a block of rooms at **The Lodge** at Callaway Resort and Gardens. The rate is \$164++ per night. Please refer to the session information sheet for details and instructions to reserve a room.

**NOTE:** Callaway's **housing deadline is May 11, 2022**, we cannot guarantee the negotiated room rate after the deadline. Callaway also has a 7 day cancellation policy, so please be sure to become familiar with all of their policies ahead of time.

**Cancellations: The ACCG cancellation deadline is Wednesday, May 4th.** Cancellations received in writing by this date will be entitled to a full refund less a \$50 administration fee. Cancellations received in writing between May 5,

2022 and May 23, 2022 will be entitled to a **50% refund**.

There will be **no refunds offered for cancellations received after May 23, 2022**, unless the participant is able to substantiate a sound reason for the late notification such as an emergency beyond the participant's control.

**Class Materials:** As is customary, class materials will be available for download from the on-line LLA library approximately one week before the scheduled class. We will send an e-mail notifying class participants when materials are available.

**Class Schedule:** Each will begin promptly at 8:30 a.m. and end at 3:30 p.m., with a one-hour lunch break.

**NO Partial Credit Given:** Partial credit will not be given, so participants must be certain they arrive to class on time.
